You Are Being Provided Notice Regarding

The Bayside Cemetery/Congregation Shaare Zedek Perpetual Care Fund Litigation.

Why is There a Notice and What Are The Settlement Terms? A proposed Settlement has been reached in the above-referenced litigation which requires Bayside Cemetery/Congregation Shaare Zedek or any successor-in-interest to maintain a Reserve Fund of \$6,500,000 in perpetuity. If you believe you are a member of the Class, you may contact the Notice Administrator (contact information below) with any additional questions regarding the Settlement or the proposed Settlement Class. The full terms of the Settlement are available at www.baysidecemeterysettlement.com, or you may call **1-877-495-0817** toll free. Alternatively, you may review the Court's docket or contact counsel for the proposed Settlement Class.

How Do I Receive a Payment? No monies will be distributed as part of this Settlement. You do not have to do anything if you agree with the proposed Settlement. If the Court approves the proposed Settlement and it becomes final and effective, Congregation Shaare Zedek and Bayside Cemetery or any successor-in-interest are to maintain a Reserve Fund of \$6,500,000 in perpetuity for the maintenance and care of Bayside Cemetery, including the lots, plots, mausoleums, and graves covered by the perpetual care contracts.

Class Member Rights May Be Affected. If you are a Class Member, and you do not want to be legally bound by the proposed Settlement, you must exclude yourself from the proposed Settlement Class. To do so, you must send a letter that includes the following: your name, address, and telephone number; a statement that you are a Settlement Class member and want to be excluded from the Settlement in *Leventhal v. Bayside Cemetery and Congregation Shaare Zedek*, Index No. 100530-2011; and your personal signature. You must mail your exclusion request, postmarked no later than **April 16, 2025**, to: Bayside Cemetery Settlement, ATTN: Exclusions, P.O. Box 173001, Milwaukee, WI 53217. If you do not exclude yourself, you will release your claims against Bayside Cemetery and Congregation Shaare Zedek concerning or relating to the Bayside Cemetery Perpetual Care Fund Litigation and will not be able to sue Bayside Cemetery/Congregation Shaare Zedek for any claim released under the proposed Settlement. If you stay in the Settlement Class, you may object to the proposed Settlement by filing with the Court and sending your objection no later than **April 16, 2025**. The Court will hold a hearing on **May 1, 2025, at 10:30 a.m. EDT** to consider whether to approve the proposed Settlement. You may file an objection to the proposed Settlement, but you must meet certain requirements. If you are a class member, you may appear at the hearing, but you are not required to attend. You may hire your own attorney, at your own expense, to appear or speak for you at the hearing. You may also attend and speak at the hearing.
